As Nurol Holding, we encourage all stakeholders within our value chain, including our Group companies, subsidiaries, businesses, and projects, to use natural resources responsibly and efficiently, minimize environmental impacts, and prioritize environmental sustainability across all areas of activity.

We are committed to embracing the following principles for the continuous improvement of our environmental conscience:

- To comply with all legal requirements for the protection of environment across local, national, and international levels in every geographic region where we operate, and to collaborate with pertinent institutions and organizations for the development of standards,
- To continuously monitor our environmental performance, identify improvement opportunities, define short-term and long-term goals alongside environmental performance indicators, and plan improvement actions,
- To take measures to combat climate change by implementing energy efficiency practices aimed at reducing energy consumption and greenhouse gas emissions, to prioritize renewable energy sources, and to actively promote sustainable solutions,
- To encourage the efficient use of energy, water, and other resources, prevent and reduce waste generation, increase recycling and reuse rates following circular economy principles, and review design and production processes aligned with these principles,
- To employ eco-friendly disposal methods for waste in cases where reuse, recycling, or recovery options are not viable,
- To identify and implement monitoring and improvement opportunities aimed at reducing our carbon and water footprints across all activities, to evaluate climate-related risks and opportunities, and to undertake initiatives that contribute to addressing the climate crisis and transitioning toward a low-carbon economy,
- To collaborate with leading NGOs and local authorities in supporting our ongoing environmental protection initiatives and to actively engage in emerging projects,
- To adopt environmentally friendly practices during our activities, to carry out activities for the protection, restoration, and continuous improvement of natural ecosystems and biodiversity, and to actively participate in social responsibility projects,
